

What is a Philippine Visa?

A Philippine Visa is an endorsement made on a travel document by a consular officer at a Philippine Embassy/Consulate denoting that the visa application has been properly examined and that the bearer is permitted to proceed to the Philippines and request permission from Philippine Immigration authorities at the ports of entries to enter the country.

The visa is not a guarantee that the holder will be automatically admitted into the country because the admission of foreign nationals into the Philippines is a function of immigration authorities at the port of entry.

Visa-Free Entry of Temporary Visitors to the Philippines

Nationals from countries listed below who are traveling to the Philippines for business or tourism purposes are allowed to enter the country without a visa for a stay not exceeding thirty (30) days, provided they are holders of a passport valid for a period of at least six (6) months beyond the contemplated period of stay, and a return or outbound ticket to their country of origin or next country of destination.
