

Republic of the Philippines Department of Transportation CIVIL AERONAUTICS BOARD ADVISORY



All airlines are advised that the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) as provided in IATF RESOLUTION NO. 114 series of 2021, approved the following:

A. Upon the recommendation of the Small Working Group on Testing and Quarantine Protocols, the following protocols shall hereinafter be observed for all inbound travellers to the Philippines, regardless of vaccination status, in all ports of entry:

- All arriving travelers shall undergo fourteen (14) day quarantine upon arrival. The
 first ten days of which shall be observed in a quarantine facility, with the remainder
 to be completed under home quarantine in their respective local government units
 of destination;
- Reverse Transcription Polymerase Chain Reaction (RT-PCR) testing shall be conducted on the seventh day with Day 1 being the day of arrival. Notwithstanding a negative test result, the arriving traveler shall complete the facility-based quarantine period of ten days;
- The Bureau of Quarantine shall ensure strict symptom monitoring while in the facility quarantine for 10 days.

C. The recommendations of the IATF Technical Working Group, as follows:

- The approval and adoption of the Guidelines on Point-to-Point Air Travel for Leisure Purposes from the National Capital Region Plus Areas of the Department of Tourism; and
- 5. Further amending the provisions on Interzonal Travel in the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as follows:

SECTION [7] GUIDELINES FOR INTERZONAL AND INTRAZONAL MOVEMENT.

2. (a) The movement of the following authorized persons outside their residences (APOR), by land, sea, or air, within and across areas placed under any form of community quarantine shall be allowed: (1) health and emergency frontline services and uniformed personnel, (2) government officials and employees on official travel, (3) duly authorized humanitarian assistance actors (HAAs), especially those transporting medical supplies and laboratory specimens related to COVID-19, and other relief and humanitarian assistance, (4) persons traveling for medical or humanitarian reasons, (5) persons going to and from the airport, (6) anyone crossing zones for work or business permitted in the zone of destination, or activities as may be authorized by the IATF, and going back home, and (7) public utility vehicle operators. The PNP shall be



authorized to promulgate and regularly update the list of APORs. Authorized shuttle services shall be allowed to travel within and across areas placed under any form of community quarantine, with priority given to persons rendering health and emergency frontline services.

ALL DOT-ACCREDITED ACCOMMODATION ESTABLISHMENTS OPERATING
AS QUARANTINE HOTELS IN METRO MANILA TO OBSERVE LATEST IATF
RESOLUTION REQUIRING ALL ARRIVING GUESTS TO A MANDATORY
FACILITY-BASED QUARANTINE FOR THE FIRST 10 DAYS OF THE 14-DAY
QUARANTINE PERIOD

The Department of Tourism advises all participating quarantine hotels in Metro Manila to strictly observe and implement the new protocol pursuant to IATF Resolution No. 114 requiring all arriving passengers to undergo a 14-day mandatory quarantine, with the first 10 days in a quarantine hotel.

Arrival protocol shall be as follows:

Day 1: Arrival/Check-in

Day 7: RT-PCR Test Swabbing Day 9: Release of tests result Day 10: Check out of QH

The said resolution shall be effective 0001H 08 May 2021 and shall continue to be enforced unless otherwise revoked.
